volunteering to run for this sometimes very thankless task. All of the candidates were wonderful and deserve our respect and gratitude.

There has been the standard Lazy River dialogue on what happens next and how are the vacancies going to be filled. I can assure you that your elected Board members worked very hard on reviewing all shareholders for potential appointees and are extremely pleased with the three who accepted the challenge to step into the Director seat for the balance of the unexpired term of office of the Director he replaces.

The process of selecting new Board Members when there is a vacancy is governed by both our By-laws Article 4.2 (f) and Florida Statute 719.106 (1)(d) 6.

The By-law states:

"If the office of any Director becomes vacant by reason of death, resignation, retirement, disqualification or removal from office, a majority of the remaining Directors, even if less than a quorum, shall choose a successor who shall hold office for the balance of the unexpired term of office of the Director he replaces."

Following our By-laws and the state law your Board selected Ted MaKowski, Keith Rule and Rich Tindall.

All three of these gentlemen, I believe, have what it takes to help us move forward.

At the writing of this article, your Board has only been in office for two days and let me tell you they have been busy. We have met with staff, reviewed current and anticipated projects, talked with potential volunteers, listened to concerns and considered Joe Abbruzzese's excellent suggestion of changing the date of the annual meeting to February and even found time to enjoy the Booster's Club Draw and Share dinner.

Hopefully we also held on January 22, 2020, after Koffee Klatch a Workshop to introduce your new Board members and to hear your positive suggestions on what we can do to make Lazy River Village even better.

Bocce court reconstruction, relocating the screen room, putting a new floor in the gazebo and addressing storm drainage issues are just the start of the list of projects on the horizon.

Again on behalf of all your Directors I want to thank you for your support and assure you that we will do our very best to meet your expectations.



What I Wish You Knew...

Having worked in this industry for over 20 years, I've seen all too often people who waited to get their hearing checked struggle during conversations. They describe the same pattern, while listening to their friend's story one word sticks out as odd, and they lose track of the rest of the story.

It's always just one word in a story that causes confusion, which results in an interruption since the story doesn't make sense. Needing to ask for help with a misunderstood word gets embarassing for the listener. Overtime they stop asking for clarity. Then they worry that everyone thinks they are always confused.

Being able to hear a story clearly is what hearing aids should do.

People think wearing a hearing aid is like wearing glasses. When you look at a flower, you see a flower. When you hear a simple noise, like a siren, you hear the sound. However, a better comparison would be listening is like reading, since both involve understanding what is being shared.

Reading is not about looking at words it is about comprehension of words. Reading a story requires you to imagine characters and what they will do. When you get caught up in a story you feel their reactions and hope for their future. You have an emotional response to the characters. You aren't just reading words, you engage in what happens.

Listening to a conversation is not about hearing sounds, it is about the words and their meaning. Listening involves the entire story, including emotions and experiences. You honor your friends by engaging with their stories.

Studies have shown that waiting to address a hearing loss will reduce the words you understand. Every time a word is not understood during a story, you will lose the flow of what is being shared while you try to figure out that one word. Missing out on words during a conversation reduces your ability to connect the words you hear to the full experience of the story.

JIM CANADAY

Jim Canaday was born October 26,1947, and raised in Council Bluff, Iowa, a town of 85,000 people, nestled in an area just outside of Omaha, Nebraska. Jim lived an unremarkable childhood and graduated from the local high school. Upon graduating, he attended Omaha Art School where he met his first wife.

At the age of 21, after receiving his draft notice, he was inducted into the U.S. Army in January 1971. Three days prior to leaving for Fort Leonardwood, Mo for 8 weeks of basic training, Jim married the mysterious girl from Art School, whom he divorced three days after he was discharged in May of 1972. (Could it have been love, maybe not).

After finishing basics, Jim received Advanced Individual Training which lasted eight weeks, during which time he showed an aptitude for typing and clerical work. He was subsequently deployed to Rahm Bay, Vietnam in the China Sea, where he became a clerk at the Supply Depot for the Headquarter Company. Jim spent eight months in Rahm Bay, and as the war was winding down in 1972, his Company was standing down (disbanding preparing to leave) and all of their guns had been taken, giving them a sigh of relief.

Two nights before he was to leave the Bay they were attacked by the Viet Cong from the top of a hill, who launched rocket mortars in their vicinity as they sat in bunkers. Some, including Jim, were given machine guns for defense in the event of a ground assault. Fortunately Jim never had to fire his weapon as the enemy never advanced. Jim believes the assault was intended more of an attempt to destroy morale. In total, they suffered 8 casualties and 25 were wounded. Jim briefly experienced the reign of horror that took so many lives in a protracted war.

In May of 1972 Jim was honorably discharged, receiving a welcomed early out. He returned to Council Bluff where he worked at a number of different jobs.

He eventually moved to Massachusetts where he spent 25 years at the Factory Paint Store in Brockton. In 1989 when attending a singles group called New Beginnings, he met the love of his life, a young widow named Heike, whom he dated and married in 1991. Heike, who worked for the State Bank of Boston, got an early out in 2011 and they realized their goal of retiring to Lazy River in Florida. Jim and Heike were no strangers to Lazy River because her parents had lived here since 1978, and they had visited many times, the house they now call home at 111 Tortola Way. Jim and Heike love to travel and have many more places on their bucket list. Jim loves playing pickleball, his music in The Other Band, and of course his Magic.

Jim, on behalf of all your friends here in Lazy River, we thank you for your service to our Military, who has kept watch throughout history that we might sleep well and enjoy the freedom that we well know is not free.


The first half is now complete and we are ready to begin our second half competition beginning January 7th.
