President. I firmly believe having a President who is truly hands on for the return of the Snowbirds during this pandemic was what was best for the Village. I have been elected as Vice President and Betty Rumley, who has really functioned as co-president, has been elected as Secretary. Rusty Shelley remains as Treasurer. Betty is also not able to cross the border at this time.

Charles Sulzbach, prior to being appointed as a Director, had been appointed as an Officer to the Board as the Assistant to the President. Charles has lived in Lazy River for 16 years, is a full-time resident and has served the Village in the past as President for three years and Treasurer for one year. I want to thank Charles again for stepping up and taking on this position.

At the past Board Meeting we addressed the issue of returning Snowbirds and what rules or policies need to be applied to keep all residents safe from Covid-19. We have not had a case of Covid-19 since March and do not want to relax our standards of safety while still in a State of Emergency. Returning residents and renters and visitors will be asked to self-quarantine for two weeks on arriving in the Village. That means no use of any of the facilities including the club house, the courts, the fitness center or the pool. Pool furniture will not be returned to the pool, nor facilities opened up until we start to see fewer than a 5% case rate within Sarasota County and Charlotte County. Walking, bike riding, golf cart riding and social distance visiting of course is permitted.

The residents who count Lazy River as their primary home have been wonderful in keeping themselves and their neighbors safe over the past five months. We cannot let our guard down just because we are excited to be back in the Village.

Returning residents and renters will have travelled by car or plane to get to Lazy River. The risk of travel must be taken seriously. Florida numbers are heading in the right direction and we would hate to see a spike in those numbers as a result of the return of the Snowbirds.

It has been an honor to be your President and I will continue to serve this wonderful community as your Vice President.

This is a free service for *Non-Emergency* falls. You can call the number listed below and they will send someone out to help you get up. While you are talking with them they will ask your ad-


dress, cross street, age, male or female and if you are injured.



Pickleball

We are still playing pickleball here at LRV. Hopefully you are too, whereever you are!

As of the submission of October's PB article, the lights are still in limbo. Our manager, Rick Silliker, is working with our electrical contractor and the Sarasota Zoning Board to come together on an economical solution to the lights to be installed on the existing light poles. Hopefully this solution will save money while keeping the pole heights, before the end of fall.

We are all adjusting to our new reality with Covid-19 virus still being prevalent in many parts of the country, people are trying to keep their circle of contacts small.

For Pickleball players, Skinny Singles may be the answer. With only one player on each side of the net, you only use half the court. You either use diagonal courts and changing the diagonal side with each serve, or use half the court directly across from your opponent. The traditional method of playing skinny singles is to serve cross-court and play cross-court into the half-of-the-court in which the serve was hit.

However, to practice "down-the-line" drop shots and volleys, the game can be played with each player positioned on the side of their court according to their own score. This means that if the score is 2-2, for example, both the server and return-of-server will be positioned on their even sides and rallies are played cross-court from even side to even side.

However, if the score is 3-2, then the server will be positioned on the odd side and return-of-server will be positioned on the even side. This results in the rally being played straight across from each other (and not cross-court). If players are not comfortable serving straight across – serve cross-court and then have the server immediately slide over.

Skinny singles is a great drill/game when there are only two people available to play. It will closely mimic the shots and strategies of a doubles game.

It is a great way to help your doubles game and work on your skills since you really have to focus on ball placement. Skinny singles is the perfect drill to practice dinks, drives, drops, serves and volleys.

What I Wish You Knew...

Having worked in this industry for over 20 years, I've seen all too often people who waited to get their hearing checked struggle during conversations. They describe the same pattern, while listening to their friend's story one word sticks out as odd, and they lose track of the rest of the story.

It's always just one word in a story that causes confusion, which results in an interruption since the story doesn't make sense. Needing to ask for help with a misunderstood word gets embarassing for the listener. Overtime they stop asking for clarity. Then they worry that everyone thinks they are always confused.

Being able to hear a story clearly is what hearing aids should do.

People think wearing a hearing aid is like wearing glasses. When you look at a flower, you see a flower. When you hear a simple noise, like a siren, you hear the sound. However, a better comparison would be listening is like reading, since both involve understanding what is being shared.

Reading is not about looking at words it is about comprehension of words. Reading a story requires you to imagine characters and what they will do. When you get caught up in a story you feel their reactions and hope for their future. You have an emotional response to the characters. You aren't just reading words, you engage in what happens.

Listening to a conversation is not about hearing sounds, it is about the words and their meaning. Listening involves the entire story, including emotions and experiences. You honor your friends by engaging with their stories.

Studies have shown that waiting to address a hearing loss will reduce the words you understand. Every time a word is not understood during a story, you will lose the flow of what is being shared while you try to figure out that one word. Missing out on words during a conversation reduces your ability to connect the words you hear to the full experience of the story.

On that Saturday, 24th of October, at the time of your appointment, you will enter into the WELCOME CENTER from the front, get your flu shot and will exit through the rear of the building to keep us safely apart.

Please be sure to bring your Driver's License or a form of Identification, and your Medicare card and secondary Insurance card. All those over 65 should request to have the "Senior" dose which will be available.

If anyone has not had a Pneumonia Vaccine since 2015, they should request one when signing up. This will alert the Pharmacist to bring extra vials with him, and Medicare will also pay for it.

It is very Important to sign up with the Office, as you need to have a definite appointment. This will keep us safer by not having many waiting on the porch of the Welcome Center. 
