President's Report



As referenced in the May/June Current we had contracted with Giffels-Webster Engineers, Inc, Englewood, FL. The (4) troubled areas of Lazy River have been inspected by their engineers and the necessary corrections are

currently being evaluated.

On August 6th, 2021 the Giffels-Webster Engineers presented LRV with a Technical Memorandum addressing:

- Surveying and repairing of Lake Frangipani, Antigua Lake and the drainage to the Martinique Canal.
- Surveying the Marina canal bank and Island Point Rd roadway for erosion and roadway stability. (Giffels-Webster Engineers, Inc.)
- Survey and repair cul-de-sac drainage across and under #102 Lazy River Rd., which includes under the driveway, the house and seawall.



Manager's Report

We have been working on the flooding issues and have spent time and labor checking all the pumps that move water from backyards to the lakes. We have replaced a couple of pumps and secured a couple



of additional spare pumps to be prepared to replace as needed.

We have had an engineering firm in to look at the erosion along the bottom of the boundary wall next to Lake Frangipani. They have provided us with a multiphase plan to manage the level of the lake and we are in the process of completing phase 1.

We will then determine if that alone handles keeping the overflow of the lake onto the sidewalk on the outside of the wall. Subsequent phases will be implemented if needed.

- 4) The Bocce Courts have fallen behind due to various problems.
- 5) Director Tom VanMassenhove will be evaluating the Memorandum and prepare a committee to develop a time frame and plan of action.

The front walls new/repaired lighting should have been completed by the end of June. Due to weather conditions and other maintenance demands our completion goal is the end of August.

As I began writing this Current's message the headlines in the Sunday paper (8/8/2021) reported the United States was averaging 100,000 new COVID 19 cases a day. The seven-day average for deaths rose from 270 per day, two weeks ago, to nearly 500 a day as of 8/6/2021. As most of us are aware, LRV is experiencing a new round of COVID-19 among our residents and personnel. It is recommended by the CDC to wear masks indoors in public places, and social distancing, 6' from others. We will adhere to the guidelines and evaluate the changing situations. We all want to be safe.

Remember, we are still in Hurricane season. Please remain aware of your neighbor and their well-being. We all need to look out for one another.

In the July/August 2021 Current I had asked our boating/kayaking community to keep the Marina ramp chain up in place, across the ramp, when not loading or unloading. It was the last sentence of my report. Maybe some of us missed it. The sign and chain are in place to keep us aware of the dangers working around boat ramps, with wet slime covered concrete, etc. If you see someone left the sign and chain laying on the ground, have the courtesy to put it back up.

Remember to replace the chain across the ramp after loading or unloading your boat or kayak.

The engineering firm gave us a plan that was implemented to move water from the cul de sac at the end of Lazy River Road, to the river, keeping the water from undercutting the driveway at address 102.

We are also looking at diverting water that collects behind 153 Lazy River Road, to the scale and off to the river.



By the time this issue of the Current is out, school will probably be in full swing. Teaching Sunday School this year for a younger group of children is causing me to go back to the basics.






If you were in Lazy River during the summer, you would find Bob Stanko on his knees, in the middle of the street, painting parking lines, curbs, fences, and even street drain grates.

Time is certainly speeding by this summer, in our lives and in the sky. I personally can't wait to get back to LRV!


We typically discuss easy sky items that can be seen just with our eyes in these articles, but with telescopic help in the fall, we will open up our discussions for new items we can observe. One of my more daunting tasks this fall will be to determine what inventory I need to bring back with me!

For this month of September, you will see an interesting lineup low in the western sky just after sundown. The chart below shows the sky at about 7:45 pm on 9/9/2021. If you have a pair of binoculars, it will help you in discerning the three planets from the star Spica. Mercury will be your prize, and for those with a good horizon you will just catch Mars before it descends under the horizon. Venus, of course, is the brightest, close to the crescent moon waxing towards full moon later in the month. Test your eyesight with a flat horizon and see how you do!


